## A RESOLUTION TO BE ENTITLED:

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PENSACOLA, FLORIDA, DELEGATING TO THE CITY MANAGER THE AUTHORITY TO REQUEST THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION TO TEMPORARILY CLOSE STATE ROADS; PROVIDING FOR INDEMNIFICATION.

WHEREAS, the City of Pensacola from time to time sponsors or grants permits to sponsors of special events which necessitate the temporary use of public property or the temporary closing of public roads; and

WHEREAS, various such special events have by tradition or actual necessity required the temporary closing of certain state roads; and

WHEREAS, the State of Florida Department of Transportation has required certain assurances from local governments as a condition for permitting the closing of the state roads for public events; NOW, THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF PENSACOLA, FLORIDA:

Section 1. The City Council hereby delegates to the City Manager the authority and responsibility for making timely application to the State of Florida Department of Transportation for its permission to temporarily close any state roads for any special event authorized pursuant to Article VI, Chapter 12-6.5 of the Code of the City of Pensacola, and to provide to the State of Florida Department of Transportation such information and assurances as may be reasonably necessary to obtain approval for the temporary closing of any said state road.

SECTION 2. In consideration of the granting by the State of Florida Department of Transportation of permission to the City of Pensacola to temporarily close a state road for a special event, the City of Pensacola shall, except to the extent prohibited by law, indemnify, defend, and hold harmless the State of Florida Department of Transportation from and against any and all claims, demands, actions, or judgments for bodily injury, including death, or property damage, arising out of or in connection with the temporary closing of a state road for a special event by the City of Pensacola with the permission of the State of Florida Department of Transportation.
